

## REFUND POLICY

Refund of entry fees will not be made for entries cancelled after the Pre-Entry deadline  
In cases where a refund is approved, \$5.00 per entry will be retained by the club for processing of the entries.

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Event Committee.

If, because of riots, civil disturbances, or other acts beyond the control of the host organization it is impossible to open or to complete a show or trial, no refund of entry fee will be made.

Every effort will be made to find all duplicate entries before processing. If a duplicate entry is processed, however, no refund will be made.

If, in the opinion of the host club, the well being of dogs, exhibitors or spectators is at risk due to extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, or extreme heat, the host club may cancel or stop a show or trial before completion. No refunds will be made in such cases.

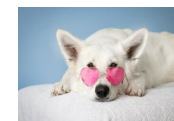

## ENTRY ELIGIBILITY

Dogs must be permanently registered with UKC, or have a Temporary Listing (TL) number except Novice Puppy in order to enter. No exceptions will be made. Entries for ineligible dogs will be returned.

Dogs must be 6 months of age on the day of the event for Conformation. For Novice Puppy dogs must be 4 up to 6 months old.

An un-entered dog may not be substituted for an entered dog.

- Conformation Licensed Classes \$30.00 per entry.
- Alternate Conformation Classes \$30.00 per entry.
- Junior Showmanship: \$13.00 (Pee Wee, Sub Juniors & Pre Juniors, Free)
- Non-licensed Classes \$18.00 per entry.
- PRE-ENTRIES ONLY
- **FUN PUPPY MATCH Saturday - 3 to 12 Month & Adult Classes - \$11.00 Pre entry only close on April 19th**

## SUBMITTING ENTRIES

Entries received incomplete, will not be accepted.

Pre-entries may be mailed or hand-delivered to the Event Secretary.

**Mailed Entries** must include the entire form, payment and be signed. Mailed entries received without fees will NOT be accepted.

## DIRECTIONS TO THE SHOW:

From Rt. 12 – at light in Baptistown, turn south on CR 519 towards Stockton. Go 1.3 miles, then turn right onto Spring Hill Road. Go 1.4 miles to the end, turn right onto Horseshoe Bend Road. Park is second drive on the left.  
From 295, Trenton & South- take 295 north. Just north of Stockton & "Prattsville Mill" (on left), bear right on CR 519. Proceed 5.5 miles through Rosemont to Fairview Road on left. Turn left onto Fairview; at "Y", bear right onto Horseshoe Bend Road.

### United Kennel Club Rules:

For exhibitors attending their first UKC show, here is a brief summary of some of the rules that you should be familiar with – this is for general information purposes, the exact wording of the rules is available in the Conformation Rule Book, and online.

1. Grooming should be kept to a minimum – no foreign substances or excessive grooming is allowed.
2. No grooming or grooming tools in the ring.
3. No bait unless the judge allows it, in which case it must not be thrown, tossed, or land on the floor.
4. No professional handlers.
5. Dogs must be kept under control.
6. Exhibitors are expected to clean up after their dogs.
7. No alcohol or illegal drugs are permitted at a UKC event.
8. UKC events are family-friendly; poor sportsmanship and foul language will not be tolerated.

All dogs need a valid permanent or temporary listing United Kennel Club registration number. Register early for a Permanent Number. For information, go online at [www.ukcdogs.com](http://www.ukcdogs.com)
